

The Chair acknowledged the impacts of Cyclone Gabrielle and the challenges it has placed on communities and government process. S Faulkner noted she is currently leading both the agricultural and regional response for Tairawhiti and expressed her thanks to NAWAC and Minister Whaitiri and MPI for their support, by way of putting the review for the Sheep and Beef Code of Welfare on hold. N Waran also discussed the devastation currently felt in the Hawkes Bay region, including the loss of life to both animals and humans. She expressed thanks to both MPI and the SPCA for the support and assistance they have provided and the general public for the financial aid the community have received.

M Stone informed NAWAC that T Brown is the newly appointed committee member, as she is an apology for todays' meeting, she will formally introduce herself at the next general committee meeting in May 2023. M Stone thanked  $^{s9(2)(a)}$  for the support she has provided as NAWAC Secretary the last year and welcomed  $^{s9(2)(a)}$  as she takes on the role of NAWAC Secretary.

39(2) introduced  $^{s9(2)(a)}$  as the new Manager of the second Animal Welfare Science Team, she officially joins MPI on 30th March 2023 and is attending todays' meeting as an observer.

#### Any other business:

Deputy chair nomination: M Stone asked the committee members to consider if they wish to volunteer for the position of Deputy Chair. The position is a one-year appointment and is primarily a contingency arrangement with no specific duties. M Stone confirmed P Mason has agreed to take this position should no one else be nominated or volunteer. The Chair requested that the women on the committee consider this role to ensure diversity.

Both S Faulkner and R Palmer expressed their endorsement for P Mason as Deputy Chair. The committee were provided a one week deadline to contact M Stone with either a nomination or any questions about the position, with the intention to pass the motion for this at the next general meeting.

The motion was put: carried.

M Stone clarified that the purpose of this meeting is to inform the full committee of any changes which have been made to the draft Codes of Welfare, as a result of stakeholder consultation and subsequent discussions held by the relevant sub-committees. As such, no decisions will be made by NAWAC today and the formal process for approving and recommending Codes of Welfare will be carried out at the next general meeting that the Codes are brought to.


### C1. Code Update: Pigs


C Johnson noted that NAWAC first saw the draft code prior to the first round of public consultation. Due to the volume of feedback received during public consultation, substantial changes were made to the code and the subcommittee underwent a second round of targeted stakeholder engagement and consulted with two experts. The current draft code reflects this process.

The three targeted engagement meeting were chaired by L Burton and were well attended by industry representatives, farmers, veterinarians and advocacy groups, to further discuss key issues which were highlighted in the public submissions.

C Johnson thanked everyone for their appreciation of the process and input.


Meeting adjourned at 10:32am. C Johnson left the meeting.
